Privacy statement

Date of inception: 18th of May 2018

This website is operated by GSC - GreenSea chartering bvba, established in Antwerp, Belgium, hereinafter referred to as 'GreenSea'.

This Privacy Statement applies to www.greensea.be.

When you visit the GreenSea website, it might be that your personal data is collected. This personal data will solely be used by GreenSea for the purposes described in this Privacy Statement. GreenSea highly values your privacy and therefore your personal data is handled with utmost care. For this, both visible and invisible measures are taken. In this Privacy Statement you will find information about how we deal with your personal data.

GreenSea will take it that when you are using the website that you agree that your personal data is used by GreenSea as described in this Privacy Statement.

The personal data which is collected and processed via this website will be used by GreenSea for business purposes only. It might be that GreenSea contacts you based on the information you have provided via the website (unless you have expressly indicated that you do not wish to be contacted).

1. Personal Data

What is to be considered as personal data?

Personal data is information that tells something about you and which relates to you. It can exist out of various items, for instance; (company) name and address details, email addresses, telephone numbers, etc.

The collection, storage and usage of your data is called the 'processing' of personal data. This is a concept of law. GreenSea complies with the laws and regulations when processing your personal data, including the rules of the General Data Protection Regulation (GDPR). Below you can read about what personal data we process and what data that may be.

Where do we get personal data?

In most cases we receive personal data from you because you take one or more products from us or deliver it to us. The law then speaks of data processing that is necessary for the preparation or execution of an agreement. The bottom line is that we cannot help you as a customer/supplier if we do not or cannot store data about you. Your personal data is only kept for duly defined purposes.

Your personal data is also used because we maintain a central customer administration and supplier administration. In the law this is called 'processing because of legitimate interests'. Finally, your data is also processed in order for us to comply with our legal obligations.

This is why we process your personal data:

- to execute our agreements;
- To provide information to and receive from other parties when necessary in connection with the execution of an agreement.;
- on the grounds of a legitimate interest;

- For central customer administration and supplier administration. GreenSea collects the following information for its central customer and supplier administration; your (company) name, your address details, other contact details, data about the product and payment details;
- To comply with the law which imposes certain legal obligations.

What personal data do we have?

- Personal data that we receive from you for the execution of the agreement. This involves: general information such as your name, address, telephone number, e-mail address;
- data to identify you;
- Your account number to receive payments from you or make payments to you.

2. Third parties

Your personal data will be treated confidentially by GreenSea and will not be forwarded and or used for other purposes as described above, nor will they be provided to third parties, unless:

- GreenSea is legally obliged to share your personal data;
- you have given express authority or requested us to share your personal data;
- We use your personal data when we want to contact you for publication and or marketing purposes.

Third parties are entities which do not fall within the GreenSea Company.

GreenSea will not use its website to collect personal information with the intention to sell this information to be used as mail-outs on behalf of third parties.

3. This is how we safeguard your personal data

We ensure good security. We spend a lot of time and attention to the security of our systems and the personal data stored therein. We keep a constant eye on the security of our data traffic. If something goes wrong, we immediately take action. We register and solve data leaks as soon as possible. Which is also a required by law. We further report data leaks to the regulatory authorities and if necessary to you. Only authorized personnel will view and process your data.

4. What are your rights?

As a customer or supplier you have a number of rights that concern your personal data. These rights can be summarized as follows:

You have the right to inspect

This means that you can ask GreenSea to identify the personal data it has stored which relates to you and how this personal data is used by GreenSea.

You have the right to adjustment, deletion and limitation

You have the right to have your personal details changed if they are incorrect. You also have the right to have your personal data removed if your personal data have been processed unlawfully, or in case they are no longer required for the purpose for which they were processed, or because you have withdrawn your consent.

- You have a Right of Appeal

You may object to the processing of your personal data if it is used by us for other purposes than necessary for the execution of an agreement or necessary for the fulfillment of a legal obligation. We will carefully review your objection and will stop processing your personal data if necessary.

5. How long is your data stored?

We retain the data for as long as required by law and as long as necessary for the purposes for which your data is used.

6. Where is your data processed?

Your data is usually processed within the European Union (EU).

7. Sharing of data within the Group of Companies

Personal data which is collected by GreenSea may be shared to other companies forming part of the GreenSea Group of companies. These companies will however only be entitled to use the data for such purposes as you have provided the data to GreenSea.

By providing data to GreenSea, we will take it that you are giving your express permission for GreenSea to share that information with other entities from the GreenSea Group of companies. You are requested to inform GreenSea should you not wish that this information is shared within the Group.
